Notice of workplace vaccinations (second time) of the Coronavirus Disease (COVID-19) jointly with Toyukyo

FIELDS Group reports that it completed the workplace vaccinations (second time) of the COVID-19 jointly with Tokyo Pachinko and Pachislot Cooperative Association (Toyukyo) for the member companies of the association and the Group's business partners.

The objective of this vaccinations is to ensure the security and safety of the pachinko and pachislot industry and everyone involved with the Group, and to contribute to the development of the industry. The vaccinations cover approximately 3,000 inoculation applicants including our Group's employees and their families, member companies of the Toyukyo and neighboring prefectural amusement cooperatives member companies, and our business partners.

*This is the second time of vaccination for the target person who has the vaccination at our Company in September 2021.

■Review of those who have been immunized

We received the following reviews from those who received the immunization.

We operate the infection control measures in accordance with strict rules to prevent the spread of infections; the employees work from home if they can, and those who need to go to office thoroughly take their temperature and disinfect.

Going forward, our Group will continue to give top priority to preventing the spread of infections both inside and outside the companies and to ensuring the safety of our business partners, participants and employees and their families, and will promptly decide and implement response policies based on policies and action plans by the government and health centers.
